Please note:

- Permission to build over a public sewer will NOT be granted for a new / proposed building.
- It is an offence under Article 236 of the Water and Sewerage Services (Northern Ireland) Order 2006 (as amended Water and Sewerage Services Act (Northern Ireland) 2016), to realign, build over or near watermains, sewers, pipes and associated works owned and maintained by NI Water unless with the prior consent by NI Water.
- Fees for inspection and approval of the works will not be discounted. The inspection fee, as noted on the SBO-A236-insp, Inspection Application form will only be payable on completion of the work and following the triage process of the submitted application form. No work must commence on site until the Assessment and authorisation of the Building Over or Near a Public Sewer Agreement has been completed and the authorised agreement returned to the applicant.
- Multiple properties with different owners/lenders must have separate applications.

- Site layout plan @ 1:100 or larger, showing location of existing sewer and manholes

(Existing NIW Combined Sewers to be highlighted in MAGENTA, Foul Sewers to be highlighted in RED, Storm Sewers to be highlighted in GREEN,

Private lateral drains should be shown in BLACK)

- o At the point that the structure crosses the existing sewer(s) the drawings must include Level of the undisturbed ground, Invert Level of the associated pipe, soffit level of the lintel, finished ground level and Finished Floor Level,
- o If the proposal includes the construction of a Manhole on the line of the sewer it must be constructed in accordance with SFA NI, the drawings must include the Invert levels & cover levels of the manholes (to be noted on the drawing).
- o All levels to be to Ordnance Datum Belfast.

All other details must be removed from the drawing.

- Longitudinal Section showing pipe size and material
- Foundation details for proposed building (refer to 'Typical Detail for Building Over Sewer')
- Manhole details showing location and depth (if applicable)
 - o If the proposal includes the construction of a Manhole on the line of the sewer it must be constructed in accordance with SFA NI, the drawings must include the Invert levels & cover levels of the manholes (to be noted on the drawing).

NI Water may request a Structural Engineer's report.

If a Building Over or Near a Public Sewer Agreement is granted:

- an application is required to be submitted for the Inspection of the Building Over or Near a Public Sewer (SBO-A236-Insp) along with the associated fee.
- you will be required to get the Lender / Mortgage Provider to endorse the Agreement. Furthermore the owner/s will be liable for payment of any fees the Lender / Mortgage Provider may charge, and any fees and outlays incurred by NI Water's external solicitors.
- The owner must notify the Home Insurance provider of their intentions in respect of these proposals.

By signing this application, you are not automatically granted approval and no works should start until approval has been granted. This application may not progress to Approval if the affected drainage has been determined during the assessment process as a Critical Sewer or for operational reasons.
