Regulation 12(5)(a) national security/public safety

NI Water may refuse disclosure where it would adversely affect national security or public safety. This exception applies here. Guidance from our sponsoring Department outlines categories of sensitive information and control measures to prevent compromising security when information enters the public domain.

Controls are required for sensitive data, including details of wholesome water sites. As this is a qualified exception, NI Water must weigh public interest in transparency against the need to protect assets and public safety. While disclosure promotes openness, it could expose vulnerabilities, making assets more attractive for malicious acts.

Current guidance prohibits releasing operational asset details that could compromise security or health and safety. Publishing such data under EIR would remove NI Water's control over its use, creating risks to infrastructure and customers. Detailed knowledge of water sites and networks could be exploited to undermine service and endanger public health.

Therefore, NI Water maintains that safeguarding wholesome water sites and related infrastructure outweighs arguments for disclosure. Any information that increases risk to the public, infrastructure, or environment must remain protected. The public interest in non-disclosure significantly prevails.
