- Under the Street Works (NI) Order 1995 a Street Works Licence is required by any person or organisation who wishes to place or retain apparatus in a street.
- Northern Ireland Water is an approved Utility Contractor and can carry out the full service connection including the excavation and reinstatement, the cost of this service will be included in the quotation.
- Northern Ireland Water, under the prescribed charges, will make the connection to the sewer and lay the associated sewers and manholes within the street.

- * One hard copy of detailed drainage layout, Scale 1:500.
- * Storm and Foul Long Sections Vertical Scale 1:100, Horizontal Scale 1:500 Invert levels to Ordnance Datum (Belfast).
- * Hydraulic calculations based on Sewers for Adoption (NI) Current Edition.
- * Site Location Plan, 1:1250 / 1:2500 map (LPS ACE map will suffice) with the site boundary clearly indicated in red and relative to an existing feature. Any other land owned by the applicant should be shown with a blue line around its boundaries, and if a public right of way exists within or adjoining the site, it should be outlined in green.
- * **Stat Charges Map**, 1:1250 / 1:2500 map, relating to this application, (LPS ACE map will suffice) with the boundary of the area served by all of the drainage constructed by the Developer (inclusive of drainage constructed by the Developer in third party lands) clearly indicated in **red**.
- * **Greenland Map**, 1:1250 / 1:2500 map, relating to this application, (LPS ACE map will suffice) with only the boundary of the area of land that the Developer owns and where he has constructed drainage, clearly indicated in **green**.

- 1. If you propose to discharge storm surface water to a watercourse, Dfl Rivers written approval with a map indicating discharge point will be a prerequisite for Article 161 Approval.
- 2. Where applicable, third party landowners written consent will be a prerequisite for Article 161 Approval.

3. Developer's Agents will not be permitted to sign the Article 161 agreement on behalf of the Developer.

- 4. Statutory Registration of formal wayleaves will be a prerequisite for Adoption of any sewers that are not located in a street, as defined by Dfl Roads.
- 5. Sewers will not be approved where reasonable access is not accommodated.
- 6. NIEA written approval for discharge of emergency overflow from foul sewage pumping station is a prerequisite for Article 161 approval.
- 7. The Bond Surety is separate to that required by Dfl Roads and covers the drainage system.
