Rush solution without pollution

High levels of the herbicide MCPA have been detected in the Eden Burn River near Ballymoney in Co. Antrim. In order to reduce these levels, NI Water are working with farmers and the local community to protect this valuable water source. This will involve a free weed-wiping service being delivered to farmers within this catchment area from April to October of 2019 & 2020.

What is the problem?

The water abstracted from the River Bann at Ballinrees is treated and used to supply quality drinking water to NI Water's customers in the surrounding area. Water quality in Eden Burn river feeding the River Bann is affected by activities on land in the surrounding catchment area. Routine passive sampler monitoring of water in the river has shown high levels of grassland pesticides such as MCPA, which could be from agricultural activity such as controlling rush infestation using a boom sprayer applicator.

Be assured that the final drinking water quality is of a high standard and meets all the required water quality standards. However extra treatment is required as a result of the water quality in the River Bann, which increases cost in order to maintain the necessary high drinking water standards for customers in the area.

What is the solution?

NI Water is working with The Water Catchment Partnership and the farming industry as part of an innovative campaign to help reduce levels of MCPA in the Eden Burn Catchment. It is planned to offer a free weed-wiping service using Glyphosate, as an alternative to spraying MCPA, to demonstrate an alternative effective rush control method which causes less pollution. The overall aim is to show that pesticide levels can be reduced in the river without the need for more expensive water treatment processes. This project will continue to demonstrate the benefits of NI Water working together with farmers and possibly doing more of these type of initiatives in future in other areas.

The project will have a Farm Liaison Officer working with farmers and land managers to manage the weed-wiping and promote better advice on handling, applying and disposing of grassland sprays, guidance on mechanical control of rushes and improving land condition to addressing the underlying causes of infestations.

What is MCPA?

MCPA is a selective herbicide specifically designed to kill weeds without harming crops and is a common active ingredient in both agricultural and domestic herbicide products. MCPA is widely used for controlling the growth of weeds like the Common Soft Rush, which has flourished in grassland following wet weather periods in recent years.

MCPA does not bind to soil particles so it is prone to leaching, directly into watercourses or via mole and land drains. Once in the water it can take 3-4 weeks to break down without treatment.

NI Water frequently detects high levels of MCPA in rivers and lakes and at abstraction points in many drinking water sources in Northern Ireland. This MCPA is removed

in the water treatment process and therefore the drinking water is of a high quality standard.

Who is involved in The Water Catchment Partnership?

The Water Catchment Partnership is a working group established with representatives from NI Water, Ulster Farmers Union (UFU), Northern Ireland Environment Agency (NIEA), Department of Agriculture, Environment and Rural Affairs (DAERA), College of Agriculture, Food and Rural Enterprise (CAFRE) and The Voluntary Initiative. The group's aim is to deliver one message incorporating the ethos from all organisations to effectively tackle the problem of pesticides in the water environment, particularly in drinking water areas.

The Water Catchment Partnership started its campaign to address significant water quality issues in Northern Ireland in 2013. The Partnership has helped farmers and land managers understand the core aspects of handling, applying and disposing of grassland sprays has provided guidance on mechanical control of rushes and has assisted in improving land condition to addressing the underlying causes of the weed infestations through community engagement at events across the Province.

Why use weed-wipers?

Rushes can be managed by using herbicides applied by either a boom sprayer, knapsack or a weed-wiper. Weed-wipers can manage rushes more efficiently than conventional boom sprayers using less chemical with a dramatic reduction in spray drift. Weed-wipers are only licensed for use with glyphosate, a chemical that has potentially less impact on water quality as it can break down quicker in around 3-7 days compared with MCPA, which breaks down in 3-4 weeks.

A CAFRE Technology Project aimed at demonstrating the most suitable methods of rush control in Northern Ireland was established in 2014. Demonstration plots were established in four different areas throughout Northern Ireland. The following control methods are in place:

- Mechanical cutting;
- Weed-wiping using Glyphosate;
- Cutting and Weed-wiping the regrowth with Glyphosate;
- Boom Spraying with MCPA;
- Liming.

This demonstrated that the area cut and later weed-wiped with glyphosate showed the most effective rush control with minimal water pollution. This method uses a glyphosate product specifically approved for use in a weed-wiper. The percentage of rush cover reduced from 81 per cent in 2014 to 20 per cent in 2015.

This was further demonstrated by the 2017 free weed-wiping trial held in the Seagahan Catchment area. This trial resulted in a rush reduction of between 60% and 90% across 426 acres. Ongoing water sampling of the reservoir has shown a positive impact reducing MCPA within the Seagahan reservoir

NI Water are providing a free weed-wiping service for farmers in the Eden Burn Catchment area between 1st April and 31st October 2019 & 2020

throughout 2017.

Based on these results this project intends to use the same method of rush control in the Eden Burn Catchment area. Weed-wiping is an effective method to use in managing rush infestations and other grassland weeds whilst posing a lower risk to water quality.

What does this free weed-wiping trial involve?

We are offering to treat rush infestations, free of charge, using a weed-wiper in the Eden Burn catchment area. The main target will be rush control on grassland and in addition other weeds such as thistles and nettles are also eligible for treatment during the project using a weed-wiper. NI Water will employ a weed-wiping contractor to do the work. You can then arrange directly with the contractor to do the work on your land at a suitable time.

The project duration is spanning over a two year period, each year NI Water will provide effective rush control treatment on rush areas within the farm holding. Any farmer availing of the scheme in 2019 is encouraged to allow follow weed-wiping in 2020.

NI Water are employing a Farm Liaison Officer to manage the project and give free support for farmers and land managers to understand rush treatments and best practice measures. If you are a farmer within the area shown on the map on the following page, we need your help and cooperation to understand the areas of rush infestation on your land and working together, we can manage the problem without posing a risk to water quality.

2017 & 2018 success for Seagahan Farmers and NI Water

In 2017 the Seagahan Free Weed-wiping project saw 426 acres of rushes successfully treated using a weed-wiper preventing 535 litres of MCPA being applied within the Seagahan catchment area. Raw water MCPA reduced dramatically in the reservoir improving water quality and reducing the need for costly treatment.

In 2018 a further 485 acres of rushes were successfully treated preventing 648 litres of MCPA being applied on the catchment area.

The Seagahan weed-wiping projects' success both with rush reduction on the land and improved raw water quality in the reservoir was due to the farmers working effectively together with the NI Water Contractor. NI Water would like to and thank both the applicants and our

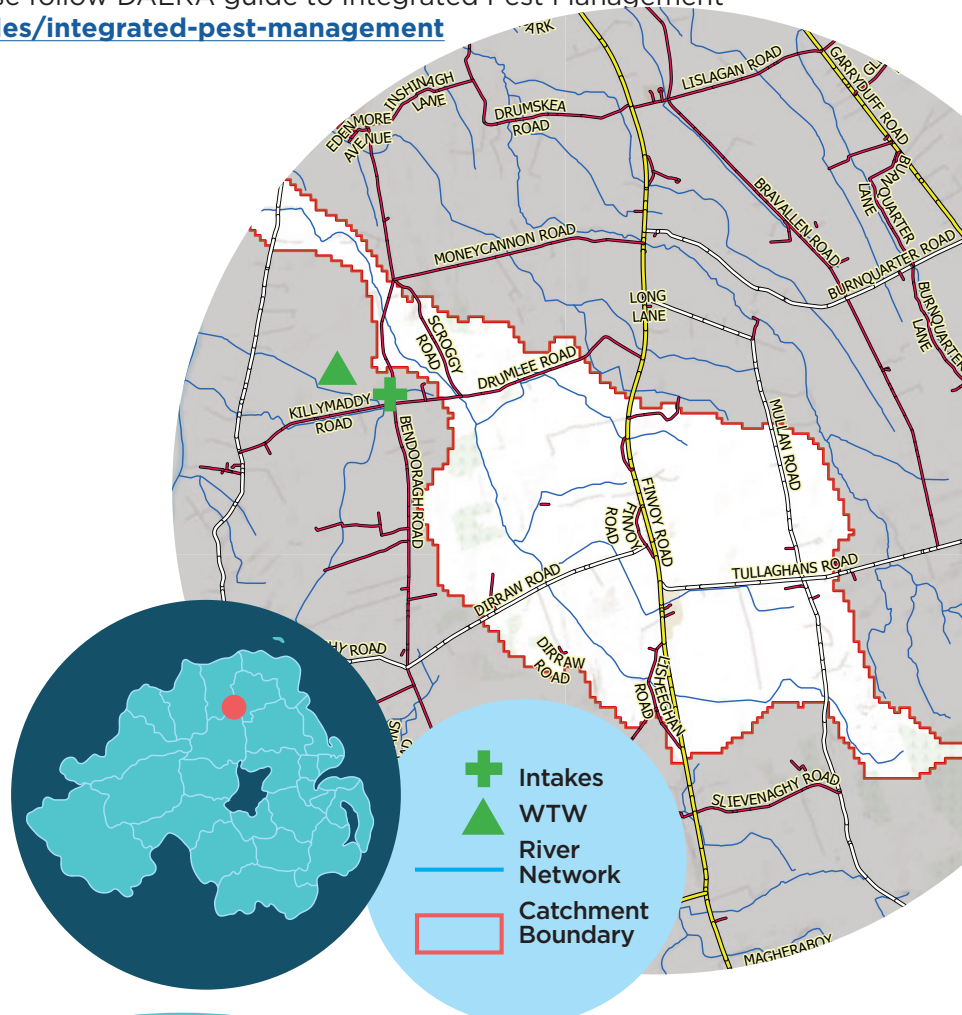

Further details and disclaimer

- The target aim of the project is to provide an alternative for MCPA use on your land within the catchment. If MCPA is used by anyone it could affect the trial results, so we are actively encouraging farmers in this area to refrain from using any pesticide product containing MCPA for the 2-year duration of the project.
- The contractor will be required by NI Water to follow recommended bio-security procedures, however if you are not content with these procedures then you should not allow the contractor to access your land and not allow the weed-wiping to go ahead.
- To make maximum benefit from the scheme, we strongly advise you to cut mature rushes a number of months prior to weed-wiping so that the contractor can then treat the re-growth, which is most effective.
- It is your responsibility to ensure that the work does not impact on cross compliance responsibilities or other schemes that you may be involved in.
- It is your responsibility to ensure that your land is not within any designated land statuses. (e.g. ASSI)
- It is your responsibility to keep livestock away from the sprayed pasture in strict accordance with the harvest interval on the Pesticide application record. It is your responsibility to deal with noxious weeds and ensure livestock are kept away from any noxious weeds within the treated area for a suitable timescale.

Who is eligible for the free weed-wiping?

The Eden Burn catchment in Co. Antrim has been selected for the free weed-wiping project. That is the area where the water runoff from land makes its way to the Eden Burn River. Only fields within this area are eligible for the free weed-wiping service. Following receipt of a properly completed application form, NI Water's Farm Liaison Officer will arrange to visit your farm and check its suitability for weed-wiping. Only fields that have a rush or weed infestation problem will be deemed eligible.

The Farm Liaison Officer's decision as to eligibility will be final.

Personal Information

What is personal data?

Personal data is information that can be used to identify a living person including property or lands information (e.g. farm data).

NI Water is the controller of the personal data that is collected in connection with the Eden Burn Weed-wiping Project because we determine the purposes for and the manner in which any personal data is processed.

The Department of Agriculture, Environment and Rural Affairs (DAERA) is a processor of personal data in that it lawfully processes a small sub-set of personal information, to ensure all weed-wiping applications meet the criteria of the Environmental Farm Scheme including location outside of environmentally designated areas.

The contractors who carry out the weed-wiping are all designated sole traders and, like all processors, have the common aim of ensuring your personal data is protected in accordance with all applicable data protection legislation, including the EU General Data Protection Regulation (GDPR) and the Data Protection Act 2018 (UK).

Lawful Processing

GDPR states there must be a lawful basis for processing your personal data. The lawful basis on which personal data of farmers and landowners will be processed in relation to weed-wiping is 'being necessary for a contract to be entered into' by that farmer or landowner.

Retention

Applications that include personal information will be securely archived and retained for two years after the end of the Project.

What data (including personal data) we collect and what we do with it

Title, forename, surname, main correspondence address, telephone number, mobile number, email address, address at which proposed work is to be carried out (if different from correspondence address), farm business ID, farm holding size, farm survey number and field number for the proposed field, field area (hectares) and approximate area of rush cover (%).

When is the application deadline?

Applications should be received by NI Water before 12th of April 2019.

What happens after application?

- The Farm Liaison Officer will contact you and arrange to carry out a brief visit on your land to determine its suitability for the proposed weed-wiper treatment and guide you through any paperwork.
- NI Water will then write to you to inform you if your application is approved.
- You should then, and only then, contact the weed-wiping contractor directly to arrange treatment dates that are suitable for both parties to get the most effective results. The date of the weed wiper treatment is dependent on the following factors:
 - Contractor availability
 - Weather forecast for period during and after application
 - Ground Conditions
 - Rush suitability as the weed must be actively growing above other vegetation (to protect grasses)
- After the weed-wiping has been completed, the Farm Liaison Officer will arrange to visit to evaluate the success of the rush treatment on your land. This will be carried out roughly 2 months after treatments take place.
- The follow-up weed-wiping will then be arranged for 2020.

The process is as follows:

Application form completed

Farmer will complete project application form and highlight fields to be treated for rushes on farm maps. Application form must be returned to NI Water before 12/04/19

Farm Liaison Officer approval

The Farm Liaison Officer visits farm concerned and agrees which fields are eligible for the project.

Rush treatment

Farmer will liaise with NI Water Contractor to complete weed-wiping at a time suitable to both parties considering ground and weather conditions.

Farm Liaison Officer post-trial visit

After completion of rush treatment Farm Liaison Officer will arrange to visit the area to evaluate the work.

2019 - 2020 treatments

The Farm Liaison Officer will contact successful applicants to repeat the process for weed-wiping in April - Oct 2020

Section 3: NI Water / Farmer Agreement

1. Date of Project: The weed-wiping project (Project) can only be carried out at each site between 1st April and the 31st October in 2019 and 2020.
2. Access: To take part in the Project you agree to provide access to treatment areas for the weed-wiping contractor appointed by NI Water (Contractor) and NI Water at all times required, including NI Water's Farm Liaison Officer. NI Water's Farm Liaison Officer will visit sites prior to any treatments and also after weed-wiping to evaluate the success of treatments. You agree to provide suitable access to water for filling the weed-wiper to the Contractor. By submitting this application you warrant and represent that you have full responsibility and control over the land in respect of which you have requested the weed-wiping to be carried out (including any access or exit routes required to be accessed by the Contractor). Where land is leased in conacre, it is your responsibility to ensure that both the tenant and the landlord are aware of and are in agreement with the Project.
3. Date of Work: You agree that once NI Water approves your application, you should make all further arrangements in relation to the trial directly with the Contractor, including agreeing suitable dates and times for delivery of the weed-wiping service. It is your responsibility to consider weather forecasts, ground conditions and the optimum stage of the rush growth, before arranging a suitable weed-wiping treatment date and time with the weed-wiping contractor.
4. Compliance with Laws: It is your responsibility to ensure that the Project is in compliance with any relevant laws required to be adhered to in respect of your land in connection with the Project, including legislation due to land designations such as an Area of Special Scientific Interest (ASSI), or conditions in any current agri-environment or DAERA scheme/regulations. It is also your responsibility to follow pesticide guidelines restricting animals from sprayed pasture in accordance with the harvest interval on the Pesticide Application Record. It is also your responsibility to ensure infestations of Ragwort or any other noxious weeds do not harm livestock (we would recommend that you follow DAERA Best Practice Guidelines available on <https://www.daera-ni.gov.uk/articles/control-noxious-weeds>, as well as any other applicable guidelines).
5. Liability: In consideration of receiving the benefit of the weed-wiping trial, if your application is successful you agree that neither NI Water nor its employees (including the Farm Liaison Officer), agents, other members of the Water Catchment Partnership or representatives (Representatives) shall be responsible for any injury, loss, or damage that may occur to you, the landowner, your land or property, from any cause, or for any other expenses, losses or liabilities (including as arising in connection with the Project and the weed-wiping services, and as caused by the Contractor), to the utmost extent permitted by law. In particular, you acknowledge that any issues with the weed-wiping services and Project shall be between you and the Contractor to resolve, and that under no circumstances shall NI Water or its Representatives be liable for (i) any special, indirect, incidental, or consequential loss or damage whatsoever, or (ii) any loss of profit, loss of use, loss of opportunity, or any cost or damage resulting from any such loss. Nothing in this Agreement shall exclude or limit NI Water's liability for anything which cannot be excluded or limited under applicable law.
6. Indemnity: In further consideration of receiving the benefit of the weed-wiping trial, you agree to indemnify and hold harmless NI Water and its Representatives from and against any and all claims, damages, liabilities, costs and expenses arising out of or relating to any injury, loss, or damage that may occur to you, the landowner, your land or property, from any cause (including in connection with the Project and the weed-wiping services).

7. Disclosure of Information: You warrant and represent that you will provide full and accurate information to NI Water and the Contractor in connection with the Project, including any information which might impact NI Water's assessment of the suitability of your farm for the Project.
8. Other Weeds: The project's primary focus will be on rush control, however the Contractor will also consider control of other weeds, e.g. thistles or nettles as part of the Project. These weeds are also eligible for treatment under the Project if they can be effectively treated using a weed wiper.
9. Use of MCPA AND Follow Up: In return for the free weedwiping, NI Water encourage you not to use any pesticide product containing MCPA within the Catchment Area for the 2 - Year duration of the Project.
10. Confidentiality: All information supplied by the farmer in connection with this agreement and project shall be treated as confidential by NI Water.
11. Termination: Both you and NI Water have the right to terminate the weed-wiping Project applicable to your farm at any point at not less than 1 weeks' notice, in your case, and 1 days' notice, in NI Water's case. Notice may be served by the Contractor or Farm Liaison Officer on NI Water's behalf.
12. Entire Agreement: This Agreement constitutes whole agreement between NI Water to the exclusion of any other arrangement or understanding between you and us, whether written or oral, relating to its subject matter.

Project Agreement

- I / We understand the responsibilities and conditions discussed previously in the information pack, application form and the NI Water/Farmer Agreement Declaration, and agree that they shall apply to my take up of the Project.
- The information given in this form is correct and I take full responsibility for it.
- A farm map showing the areas proposed for weed-wiping must accompany your completed application form.
- Applications will be accepted until 12th of April 2019.. In exceptional circumstances, applications will be accepted after this date.

I hereby declare that I am in acceptance of the requirements of the NI Water/Farmer weedwiping agreement 2019 & 2020 as detailed below.

This declaration must be signed by the person who is responsible for actively farming the land.
